#### 14. How the project was made successful?

The project has been completed successfully with the support and guidance of FVTRS and at the local level with close coordination with Panchayat Raj Institutions, Gram Sabha and at the Block level Janpad Panchayat of Baihar block nicely supported project. The organization conducted training at the community level to ensure full participation of the trainees. The staff of the project and other project staffs of the organization works hard to conduct skill training effectively. Panchayat provides good support to conduct trainings, especially EDC training, the venue and sitting arrangements made by the local panchayats. The project area is quite far from district and block head quarter, it was difficult to bring more govt. officer to the training, but we tried and bring some govt. official to visit training, i.e. DIC, CEO and ADEO etc. The certificates has been distributed by the Sarpanch.

All the trade was new and few difficult to mobilize youths for training. Lots of discussion and presentation has been made at the village level for drop out youths. All trades are very effective and profitable but the present scenario is not in favor of these trades. This needs more marketing and advertisement. In future there will some good enterprise of all trades, the trained youths are interested and trying to establish own enterprise.

The project has been over in the month of April, but the work of organization has been started because we are continue working with trained youths to motivate them and monthly we are organizing one meeting of these trained youths. We know the trained youths need regular motivation, guidance and support. Our field office which is situated at KHARJA village, coordinating monthly activity, organization is committed to do follow-up training also if youth required. We have setup an resource centre at the KHAJRA office, where all information has been kept for the youths related with training and EDC.

CDC has been developed some market linkages for trained youths, specially for NTFP/Food Processing and SMB. Trained youths are in process to submit application for bank loan / scheme. KVIC officials interested to give loan for this trade.8 youths have submitted their application to Janpad Panchayat for SMB machine, the process is going on.

#### 15. Problems encountered is any and how were they addressed?

To conduct skill training is always challenging, first time organization conducted fulltime skill training for youth. We have learnt very much things related to organizing training in systematic way. There was some problems related to power supply, which we solved with generator set. Timing of training, because most of the trainees were main earner for the family. The training conducted as per availability of trainees. During crop season timetable made flexible as per demand of trainees. This type of problems comes during the training

and we tried to solve at our level.

We face problem to register trained trainee with Employment Exchange because of long distance, trainee are around 140 KM from the district, As trainee has available time and money they come to employment exchange to register. Till date 30 trained youths has been registered/updated the status with employment exchange.

16. How is/was the follow-up done/planned? Bank linkages/employment cells/marketing/

4 youths has been submitted their project report to DIC for group enterprise. One group also got order to supply 60 thousand brick. DIC representative has been visited training and discussed with women trainees for setting up enterprise. DFO of Kanha Tiger Reserve also suggested to make tie-up with SANJIVNI outlet of forest department for selling of their Ayurvedic product like TRIFAL. Few entrepreneurs has got some small supply order. Most of the trainees interested to invest their own small money to start their own enterprise. Around 40 trained youths has been registered with employment exchange, by coming few months all will be registered with Employment Exchange at Balaghat

17. Which certificate did you give after completion of training?

Certificates signed by Executive Director FVTRS, Executive Director of CDC and Course Facilitators, provided to all trainees. We are in process to register all trainees to get artesian card from Ministry.

What are the important learnings you want to communicate from the project?

Skill development is very important for making people empower, long-term vocational training develop vision of entrepreneurship among the trainees. To do maintain or high moral of Drop out youths need to continue follow up for a long time. We could not leave the trained youths after completion of the training, they need hand holding support and motivation. Organization learnt the system to run the vocation training, before that we were not done this type to systematic training, FVTRS made very good system which we learnt and in future we will be able to apply with our other programme also.
